

Board Member Commitment

I will also be able to discuss internal programs, goals, activities, and status with the staff and Board President; additionally, I can request such opportunities.
- 3. The organization will help me perform my duties by keeping me informed about issues addressing financial, economic, legal or operational challenges.
- 4. I will be offered opportunities for professional development as a Board Member.
- 5. Board Members and staff will respond in a straightforward fashion to questions I feel are necessary to carry out my fiscal, legal and moral responsibilities to this organization. Board Members and staff will work in good faith with me towards the achievement of our shared goals and advancement of the organization's Mission.
- 6. If the organization does not fulfill its commitments to me, I can call on the Board President and Director to discuss the organization's responsibilities.
